Get ready for the 1st ever SECA Community Day. This event will take place on Saturday, April 25th 2020 from 8am-2pm. Included in this event is a Youth Fishing Derby(8am-12pm), Community Yard Sale(8am-2pm) and SECA Open House(8am-2pm). We have spaces available for the community at our yard sale and for food truck vendors at our open house. Set-up is from 7:00am-8:00am and every vendor will have a designated area. If you need to make arrangements for a different set-up time, please contact us.

Yard sale space is available at the following rates: \$15.00 for the first 10x10 space with a 6 ft table(any additional space would be \$10 per space), you can also add a 10x10 space with 6ft table inside in case there is inclement weather on the day of the event for an additional \$10.00 . Rental fees for food trailers are \$50.00. You will need to bring tables, chairs, signs, etc. This event is rain or shine, so be prepared. No electricity can be provided!

We reserve the right to approve all applications to enable us to provide a variety of merchandise and food for family fun. Vendor registration will be accepted on a first come first serve basis due to a limited number of spots for each type of space. You must return your contract with payment by April 11, 2020 to guarantee a spot. Please contact SECA at (717) 806-0123 or email at seca@epix.net if you have any questions.

Parking for one vehicle is allowed at each space. Please plan to park and stay for the entire event. There is no route for in and out traffic. Other vehicles are encouraged to park in the public lots around SECA Park.

Article 2 Terms and Conditions

Read carefully, fill in the blanks, sign and return.

1. This agreement must be completed and signed by Vendor and returned to Sponsor on or before April 11, 2020 (for First Priority guarantee) with the appropriate fees and shall not be in effect until accepted and signed by Sponsor.

2. Vendor agrees to abide by the rules and regulations for SECA Community Day 2020 and any changes thereto shall be provided to Vendor prior to the start of event.

3. Vendor agrees to sell only those products listed and approved by Sponsor on page 1 of this agreement.
4. Vendor is responsible for supplying its own personnel, tables, chairs, signs, etc. and for maintaining all liability insurance and any other insurance that may be necessary.
5. Sponsor is not responsible for Vendor's property.
6. Vendor agrees to indemnify and hold Sponsor, Sponsor's officers, volunteers and any one associated with Sponsor harmless from any and all loss or damage to Vendor, Vendor's employees or another person on Vendor's property attributable to any act or omission of Vendor or Sponsor.
7. Vendor agrees to abide by all borough, state and federal rules applicable to it and its activities at SECA Community Day 2020.
8. This event will be held **Rain or Shine** and it's the Vendor's responsibility to be fully prepared for inclement weather.

Article 3 Termination

Sponsor reserves the absolute right to terminate the Agreement in the event Vendor sells or attempts to sell any product or service other than those specified in Article 1 or breaches any of the regulations for SECA Community Day 2020. In the event the Sponsor terminates the Agreement, Vendor shall immediately cease any activities at Community Day and remove all equipment, personnel and other property from Community Day venues and forfeit all fees paid to Sponsor.

 Food Trailers-\$50.00

All funds for space must accompany this application/agreement. Cancellation penalties: Prior to 50 days-full refund. 50 to 30 days prior-50%, cancellation 29 to 0 days prior-no refund.
