# Holiday Tree Decorating Contest



You are invited to participate in a Holiday Tree Decorating Contest at SECA (Southern End Community Association) – with a charitable twist!

Religious organizations, non-profit organizations and service clubs are encouraged to apply!

You will need to provide your own tree, 5 to 7 feet tall, with a stand and all decorations. It can be live or artificial. Electric will be provided to light the tree as well as a space in a pavilion to display it during our Santa in the Park event on **Sunday, December 19, 2021, from 6 to 9 pm**. There is no cost to enter, but you must complete and return the official entry form to be considered.

## Contest Rules:

1. The event is limited to 1 entry per group.
2. The submission of a completed entry form is required no later than December 13, 2021, by 4 pm at the SECA Center.
3. You must provide all decorations for your tree. You are free to express your creativity and originality, but we ask that your tree represent your organization and be in good taste, suitable for family event.
4. Decorations should hang on the tree, not sit alongside the tree or be held up by any means other than the tree itself. SECA reserves the right to remove any decorations not meeting this criterion.
5. Any decorations can be used as long as they do not include electrical parts. Lights on the trees will be lit during our Santa in the Park Event, December 19<sup>th</sup>, 6 pm to 9 pm.
6. Please provide a sign identifying the group or organization that decorated the tree, to be attached to the donation bucket-which SECA will provide for voting.
7. All trees are to be in place between 2-5 pm on Saturday, December 18<sup>th</sup>.
8. Please remember that the trees will be outside and subject to weather conditions that may be unpredictable. You may touch up your tree before the lighting on the day of the event.

## Judging:

The public is invited to cast their votes during our Santa in the Park event by placing a monetary donation in the bucket of their favorite organization's tree. The top three trees that collect the most donations by the end of the evening will be awarded an additional cash prize with amounts to be determined by our sponsoring organizations.

Votes/Donations may be cast by anyone attending the event. The winning trees will be announced on Facebook and our website the following Monday morning. Photos will be posted on our social media as well. Winners will be notified by phone, text or email.
